

REGULATIONS OF THE FUSELLIAMOTM ASSOCIATION

Premise

The FuselliamoTM Association, on the basis of the rules of its Statute, stipulates the present “Internal Regulations” which is an integral part of the Statute itself and is valid for all present and future members of the FuselliamoTM Association.

Art. 1 Duration and change

This regulation starts with the approval of the assembly of the members. It will be valid until the assembly, on the proposal of the Board of Directors, will not modify it.

If at least 60% of the members submit a written request, by registered letter to be sent to the Association’s headquarters, in order for this regulation to be revised and modified in some parts, the Board of Directors is obliged to examine the request and re-discuss the regulation at the meeting.

Art. 2 How to register a member

The aspiring member is bound to accept the content of the statute and internal regulations. The registration form will be provided to the aspiring member in paper or electronic form. The aspiring member must complete the registration form, prepared by the Board of Directors, in which he will report his personal data that will be used for official communications. The member can request, in writing or electronically, the variation of data to the Board of Directors which updates the Register of Associates. The completed registration form must be sent electronically, by ordinary post to the Association’s headquarters or directly to a member of the Board of Directors. The Board of Directors, within 60 days from the date on which the application was received, communicates the result of the registration to the member through the contact details provided. The payment of the membership fee must be made by bank transfer or Paypal to the coordinates indicated on the official website of the Association or direct to a member of the Board of Directors within 30 days of the admission notice.

Art. 3 Duration of the membership fee

The membership fee is valid for the solar year of issue.

Art. 4 Founding members

The founding members manage in complete autonomy the publication of the magazine “Fuselliamo, il tombolo secondo noi”, free of charge and pursuing the aims of the Association. The founding members are a member of the Board of Directors. For the rights and duties see the Statute of the Association.

Art. 5 Effective and Honorary Members

For the rights and duties see the Statute of the Association (only in Italian).

Art. 6 Members’ rights

For the payment of the membership fee, the member is entitled to:

- attend the meeting with the right to vote (as long as they are over 18)
- participate in the activities promoted by the Association
- to make money donations as donations
- resign at any time without prejudice to full payment of the membership fee due.
- enjoy the facilities described in Annex A.

Art. 7 Intellectual property of contributions

Contributions of ideas, articles, publications, drawings, photographs, videos, texts, ect. provided by the members in any way (by-hand, mail, e-mail, social network, etc.), when not otherwise agreed in writing with the Board of Directors, are to be considered property of the Association that has at its disposal. Members, when not otherwise agreed in writing with the Board of Directors, may dispose of their creations for their blogs, websites, publications, etc. without having to pay any fee to the Association

Art. 8 Participation in the Association’s initiatives

The members have the right to participate in the activities proposed and organized by the Association upon payment of the expenses contribution established by the Board of Directors. Once enrolled in these activities, the members undertake to participate regularly and consistently so as not to damage the other participants and allow the proposed initiative to be carried out properly. In the event of repeated failure by the member to fulfill the obligations set out above, the Board of Directors reserves the right to declare the member expired with communication.

Art. 9 Care of spaces, goods and facilities managed or used by the Association

The members of the Association are required to take care of the livability of the spaces in which the activities of the Association are carried out and to keep intact the assets used. In the event of damage or degradation of the spaces or goods and the presence of clear individual responsibilities, the Board of Directors has the right to impose on the member in default the restoration of the initial situation by charging the expenses to the member.

Art. 10 Amount of the membership fee and conventions

The amount of the membership fee is established annually by the Steering Committee.

The member in good standing with the membership fee can enjoy the agreements established and approved by the Board of Directors.

Art. 11 Concluding provisions

For all that is not specified in this regulation reference is made to the Statute of the Association.
